8.3 Budget 2014/15: The Clerk reported that she had that day received correspondence from TBC regarding the Parish's precept for 2014/5. Indication from central government is to expect a reduction in funding by around 15% for the forthcoming year. However this was not the case for Deerhurst as the community support grant was £367 last year and proposes to be £1130 for 2014/15. The Clerk circulated a draft budget which she went through with the Councillors and some amendments were made. It was proposed to increase the number of cuts for the grass cutting from eight to twelve which should make all the areas look tidier after cutting as large clumps of grass would not be left. It was agreed that the Clerk would produce another draft and bring it back to the January meeting for ratification but initial thoughts were to keep the precept at £6,000. Clerk to contact Ken Preece to obtain a quote for verge cutting for next year and also to put a separate column in the budget for VAT.

9 MATTERS ARISING

9.1 Joint Core Strategy, Tewkesbury Borough Plan & Flood & Water Management SPD: The Clerk reported that the consultation period will now end on the Friday, 13 December. It was agreed to respond to the Flood and Water Management SPD as per Councillor Smith's comments but adding that the Parish Council support Sustainable Drainage System.

Councillor Pollard entered

Councillor Pollard reported on his attendance at the Service Village Meeting Forum which he had just come from. 880 houses will be the target for the 15 Service Villages to provide. It is unclear whether houses already built from 2011 will be taken into account. Questions were asked what the criteria were to be classed as a Service Village. It was agreed that Councillor Pollard would put some comments together in response to the JCS and Tewkesbury Local Plan and these would be sent to the Clerk prior to the 13 December.

9.2 BMX Cycle Track at Apperley Village Hall: Councillor Morris reported that following advice that the track should have some gravel compacted down on top of the soil he had some available which he will deliver to the site. He plans to get Scott Gibson and his friends to spread the gravel and compact it in. The notice he had made was not up yet but the current notice was situated between the track and allotments. The Chairman said that Scott needs to think of some ways to raise some funds as the track has involved much more cost and work than first anticipated.

9.3 Apperley Village Hall, Playing Field/ Play Area/Football Club:

Play Area: Nothing to report

Football Club: The Clerk said that she was liasing with Wayne Lippett regarding winter fixtures and whether extra cuts were required. As the pitch had just been cut it should be OK for the December fixture.

9.4 Highways: Highways Sign on A38: This had still not been repaired. Clerk to chase. Also the Chairman reported that some of the lamp standards are leaning.

High Kerb by Oaklands: The Chairman reported that he had received several complaints regarding the bollards that have been erected to warn people of the high kerb. Councillors felt they were not fit for purpose and their original request for some fluorescent paint was a much better solution. Clerk to take this up with Richard Waters at Glos Highways.

- **9.5 Deerhurst Walton Flood Alleviation Scheme:** Councillor Smith reported that detailed designs had been done and they are going to tender. Materials are already being purchased. The Parish Council agreed to act as the facilitator when built for the legal agreement.
- **9.6 Public Rights of Way:** Councillor Pollard reported that the meeting scheduled for the 19 November unfortunately had to be cancelled. Councillor Morris said that two gates had been delivered to him with 4 posts but these were not suitable as pedestrian gates to replace the stiles. Councillor Pollard said he would speak with Ian Soule.

Councillor Morris said he was looking at putting in a barrier on the Sabrina Way at the top of Hoo Lane to stop vehicles.

- **9.7 Playing Fields Renewal of Lease:** The Clerk had sent an email to Mr Leeke for an update on the situation but had not received any update.
- **9.8 Police:** The Clerk had circulated the police report prior to the meeting. No crimes for the month. Contents noted.
